Terms & Conditions

1. Space at OPD new building premises may be allotted to carry out canteen. Services.
2. Rent for the spaces are to be quoted bidders. However the rent should not be less than the 7500 (Rupees Seven Thousand five hundred only) monthly rent fixed by the institute.
3. Power supply will be given by the Institute. But energy charges will have to be borne by the bidders. Bills for energy consumption will be given by the Institute which has to be paid within seven (07) days from the date of receipt.
4. Working time will be from 08 AM to 05 PM. Rates of items should be reasonable and similar to market rate.
5. Only readymade snack may be served in the tea corner.
6. Eco friendly disposable glasses and plates will have to be used for serving food items.
7. Disposal of waste materials will be the responsibility of the bidders.
8. Keeping the canteens space clean and hygienic will be the responsibility of the bidders.
9. Monthly rents have to paid within 5th of every month.
10. Security deposit amounting to 10,000/- (Rupees Ten thousand only) in the form of call deposit FDR/NSC/ Pledged in favour of Director, LGBRIMH, is to be deposited by the bidders at the time of allotment.
