

 - Ball Point Pen (Blue Ink)
- Candidates will not be allowed without photo identity proof in original.
- Candidates should reach the Examination Hall before 30 minutes of the scheduled time of examination and **shall not be allowed to enter in the Examination Hall after 10 minutes of start of examination.**
