- ii. EMD of Rs. 3000.00 in the form of DD/FDR/BG in favor of Director, LGBRIMH, Tezpur payable at Tezpur, Sonitpur, Assam or proof of EMD exemption should be submitted.
- iii. Valid Authorization letter from Manufacturer of control, if quoted by other than Manufacturer.
- iv. Annual turnover of the quotationer for the last 3 Years from Chartered Accountants should be submitted.
